**What these bills do:**

Calls for the development of new regulations for dog boarding and daycare businesses.

**Why You should Oppose these bills:**

Has there been so much trouble with these facilities that increased regulation is being demanded by the public? It certainly hasn't been public news. The list of proposed aspects of future regulation for dog boarding and daycare is excessively long and intrusive and often subjective. It would require burdensome amounts of bookkeeping and expense both for the businesses and for the Ag Department, which would have to oversee them. The department doesn't have the personnel to handle this, so more important work would get neglected. Much of the subject matter is too subjective for fair enforcement. As for "staff qualifications and development," have the sponsors of this legislation found out whether courses for the required employee training and certification even exist? Training requirements would make it more expensive to hire employees and run a business in what is already a very poorly paid profession. Requiring such employees to get a lot of extra education is unreasonable. There are certainly not enough such schools, and these requirements would raise the price of dog boarding and daycare out of reach for many people. As for certifying employees in dog handling, body language interpretation, and breed familiarity, these would require overly subjective judgments. Requiring emergency response training also seems excessive. This bill acts as if special courses and professional degrees take precedence over what really matters in animal care -- talent, sensitivity, and experience.
